West Coast Industries confirms the products listed can be manufactured to meet Healthier Hospitals' Safer Chemicals Healthy Interiors guidelines, which require all products to meet the criteria below:

FORMALDEHYDE

Products must comply with ANSI/BIFMA Furniture Emissions Standard (M71/X71-2011 R2016), ANSI/BIFMA e3-2011 7.6.1 and 7.6.2.

PERFLUORINATED COMPOUNDS (PFCS)

Fabrics must not use water or stain-repellent treatments that contain perfluorinated compounds. Customer's own materials (COM) must comply with the same guidelines.

POLYVINYL CHLORIDE (PVC)


Products must not contain PVC. Components that constitute less than 1% of the product by weight are exempt. To avoid PVC for laminate tops, specify edge details listed in exclusions notes.

ANTIMICROBIALS

Fabrics must not be treated with an antimicrobial process. The customer is responsible for customer's own material (COM) compliance.

FLAME RETARDANTS

Product and fabric must not use any flame retardants. Customer's own materials (COM) must comply with the same guidelines.
